### TP32MTT.03.A/B/C AIR AND SOIL TEMPERATURE PROBES

The TP32MTT.03.A/B/C temperature probes measure the air and/or soil temperature by means of a 4-wire Pt100 sensor.

They are provided with a protective screen which allows to detect the temperature without that the measurement is influenced by solar radiation. The position of the sensor inside the screen is such as to prevent it from being invested by radiation. The screen is made of UV-resistant ASA technopolymer, with low thermal conductivity and high reflection.

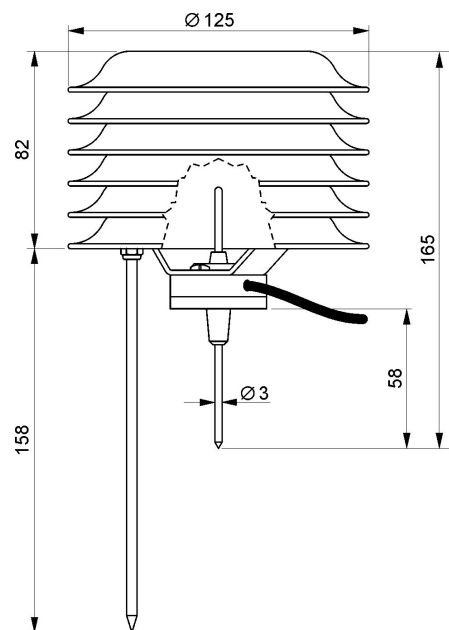
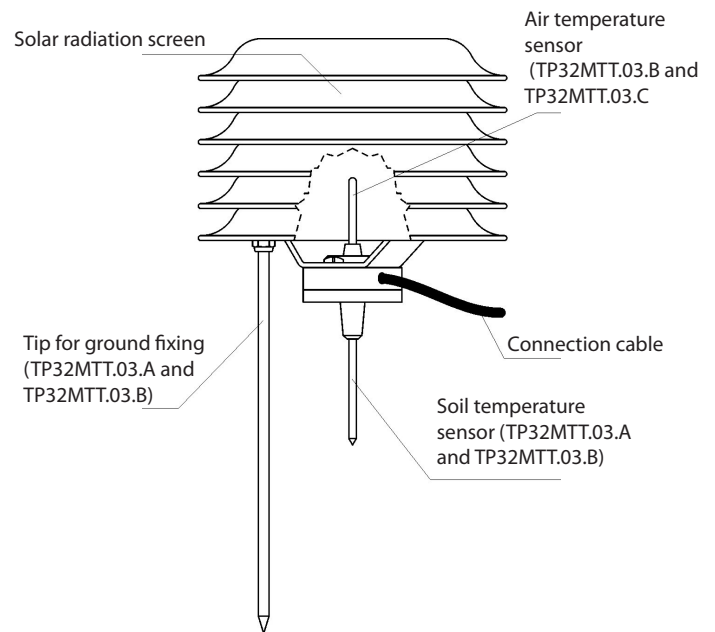
There are single probes available, for the measurement of only air or soil temperature, and a double probe for simultaneous measurement of the air and soil temperature.

- **TP32MTT.03.A** : single probe for the measurement of the soil temperature at a depth of 5 cm
- **TP32MTT.03.B** : double probe for the measurement of air and soil temperature at  $\pm 5$  cm from the soil
- **TP32MTT.03.C** : single probe for the measurement of the air temperature

The probes TP32MTT.03.A and TP 32MTT.03.B are fixed by means of a metal spike to be driven into the ground. The probe TP32MTT.03.C is attached to a bracket made of Anticorodal aluminium, powder coated, white.

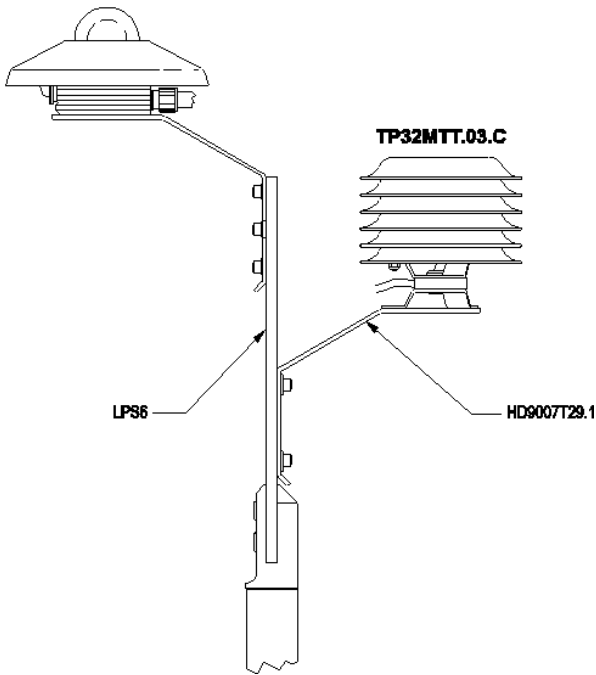
Length of the cable 2, 5 or 10 m. The cable is terminated with open wires.

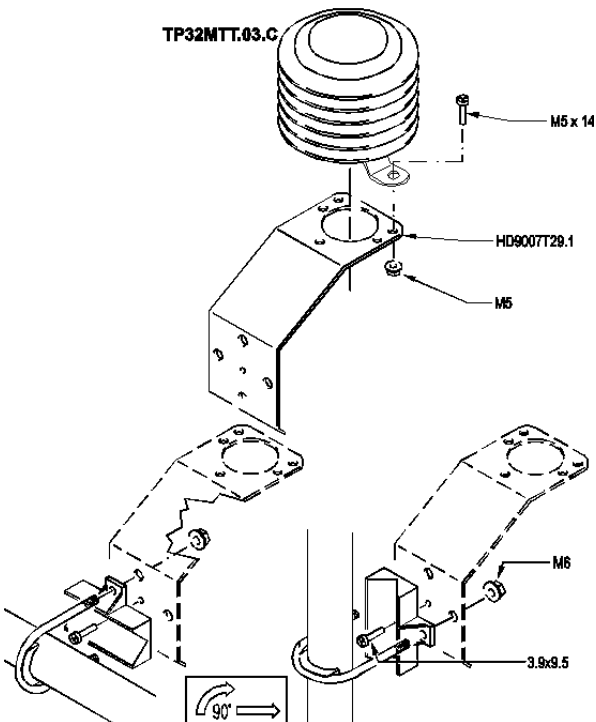
## INSTALLATION

The probe TP32MTT.03.C for the measurement of only air temperature can be fixed on a flat support by means of the bracket HD9007T29.1, or on a mast having diameter from 25 to 44 mm by means of mounting kit HD9007T29K.



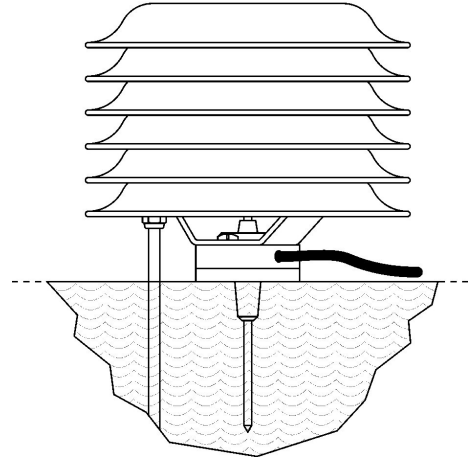
Installation with HD9007T29.1 bracket

The probes with soil temperature sensor TP32MTT.03.A and TP32MTT.03.B are fixed by inserting their metal tip into the ground. The connection cable must remain above the soil level.

Installation of TP32MTT.03.A and TP32MTT.03.B on the ground

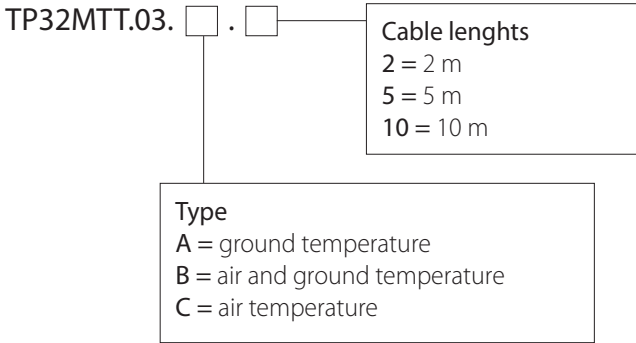

## ORDERING CODES



**TP32MTT.03.A:** Probe with 4-wire Pt100 sensor for the measurement of the soil temperature. With solar radiation screen. 4-pole cable terminated with open wires. Length of the cable 2, 5 or 10 m.

**TP32MTT.03.B:** Probe with two 4-wire Pt100 sensors for the measurement of air and soil temperature. With solar radiation screen. 8-pole cable terminated with open wires. Length of the cable 2, 5 or 10 m.

**TP32MTT.03.C:** Probe with 4-wire Pt100 sensor for the measurement of the air temperature. With solar radiation screen. 4-pole cable terminated with open wires. Length of the cable 2, 5 or 10 m.

**HD9007.T29.1:** Support bracket made of Anticorodal aluminium, powder coated, white. Includes screws for fixing on a flat support. For air temperature probe TP32MTT.03.C.

**HD9007.T29K:** Support bracket made of Anticorodal aluminium, powder coated, white. Complete with accessories for fixing on mast Ø 25...44 mm. For air temperature probe TP32MTT.03.C.
